News about the RECYCLING !!!!!!!

The new ordinance has been put in place by City Council in an effort to prolong the life of our dump. The idea behind the separation is to reuse more of our trash, which means that less waste is sent to the landfill.

RECYCLING GUIDELINES

These are the containers inside the sheds.

CO-MINGLED CONTAINERS (bottles and cans) Only:

- Aluminum Cans and Foil
- Number 1 and number 2 Plastic (with screw tops)
- Tin (steel) cans
- Mixed color glass

NEWSPAPER: Only newspapers and inserts **OFFICE PACK Only:**

- White typing and copy paper
- Pastel & yellow (legal) pads
- Computer paper
- Envelopes (windows OK)
- Staples & paper clips OK
- Sticky notes OK

No: Neon/dayglow paper Plastic mailing envelopes File folders

The container for cardboard is a small dumpster located in the Maple Lane shed only.

CARDBOARD- please breakdown all boxes!

Only corrugated cardboard and brown grocery bags

No: Paperboard (cereal or 6-pack boxes) File folders

LEAVES AND LAWN CLIPPINGS ONLY:

- Leaves
- Lawn clippings

No: Twigs
Dirt
Rock

The containers outside are for leaves and grass clipping only!

Twigs and small branches are ok to put in the dumpster.

Please help protect our environment and participate in this program. You can also take all your recyclables to the recycling center at Rio Grande Park.

The Dumpsters are to be used for household trash only.

Please do not put the following objects in the dumpster.

Do not set them next to the dumpsters or sheds. It is your responsibility to have them disposed of correctly!

BATTERIES, OIL, PAINT, TIRES, APPLIANCES, or FURNATURE.

ASH- There is a small metal can for this.

NO MATRESSES!!!!

NO MACHINERY!!!

ANY RADIOACTIVE, VOLATILE, CORROSIVE, HIGHLY FLAMMABLE, EXPLOSIVE, BIOMEDICAL, INFECTIOUS, BIOHAZARDOUS, TOXIC, OR OTHER HAZARDOUS MATERIALS AS DEFINED BY LOCAL, STATE, AND NATIONAL LAWS.

These items need to be disposed of properly. For disposal call the Pitkin County Landfill.

When these items do end up in the dumpster, we are charged a fine. We will pass the fine on to all homeowners in the way of increased assessments.
